# 11. 帰国後のフォローアップ

独立行政法人日本学生支援機構(JASSO)では、帰国後のフォローアップ事業として、帰国外国人留学生短期研究制度、帰国外国人留学生研究指導事業を行っています。

### (1) 帰国外国人留学生短期研究制度

留学を終え、現在自国において教育、学術研究又は行政の分野で活躍している帰国留学生に対し、我が国の大学で、当該大学の研究者と共に短期研究を行う機会を提供するものです。

- ① 対象者 開発途上国・地域等の国籍を有する帰国留学生
- ② 資格要件 帰国後1年以上経過している者で,満45歳以下の者
- ③ 研究期間 60 日以上 90 日以内
- ① 支援内容(平成27年度)外国人研究者に対し、1)往復渡航費、2)滞在費(日額11,000円)を、受入研究者に対し、3)受入協力費(定額50,000円)を支給

# (2) 帰国外国人留学生研究指導事業

留学を終え,自国の大学や学術研究機関で教育,研究活動に従事している帰国留学生に対し,我が国における留学時の指導教員を現地に派遣し,研究指導事業を実施するものです。

- ① 派遣対象国 開発途上国·地域等
- ② 派遣期間(現地滞在期間) 7日以上10日以内
- ③ 支援内容(平成27年度) 往復渡航旅費,滞在費(現地滞在日額16,000円),研究指導経費(上限100,000円)

# 11. Follow-up Services

The Japan Student Services Organization(JASSO) provides follow-up services for former international students to support the activities of those who wish to continue their research upon returning to their home countries. Services include: (1) Follow-up research fellowship, and (2) Follow-up research guidance.

### (1) JASSO Follow-up Research Fellowship

The JASSO Follow-up Research Fellowship is aimed at former international students from developing countries and regions who are currently engaged in the fields of education, academic research or administration, mainly in their home countries. This fellowship gives them an opportunity to visit Japan again for short-term research at Japanese institutions.

#### ① Intended For:

To have nationality of developing countries and regions etc

### ② Eligibility:

Former international students whose age is 45 or younger and at least one year must have passed since they returned home after study in Japan.

### ③ Period of Fellowship:

The length of stay for this fellowship applicable to former international student ("recipient") is 60-90 consecutive days.

## 4 Fellowship Benefits (2015):

Round-trip Airfare, Daily Allowance(JASSO provides living allowance of \( \xi 11,000 \) for each day of the fellowship recipient's stay.) Remuneration for cooperation (JASSO will provide the fixed 50,000 yen to research advisor as remuneration for cooperation in receiving the recipient.)

#### (2) JASSO Follow-up Research Guidance

JASSO supports the dispatch of research advisors to visit former international students who are currently engaged in educational or research activities at universities or research institutes in their home countries/regions, for the purpose of research guidance, lectures at seminars/symposia, etc. The objective of this program is to further polish the knowledge and research methods that the former international student has acquired in Japan and also to promote academic exchange between local researchers and Japanese researchers.

## ① Eligible countries and Areas:

Developing countries and regions.

#### ② Period of Implementation:

The length of stay in the dispatched area is 7-10 days

#### ③ Expenses (2015):

Round-trip Airfare, Daily Allowance (JASSO provides lump-sum 16,000 yen for each day of stay in the dispatched area.), Expenses for Guidance (JASSO provides expenses for research guidance. (Upper limit of ¥100,000 per research advisor))
